H2Global Instrument – Huge International Interest in the Market Consultation

BET supported HINT.CO to address the issue of risk management along the PtX value chain to minimize risks for HINT.CO and to take into account the special requirements of HINT.CO, which is not to be established as a conventional midstreamer.

Today, the Federal Ministry for Economic Affairs and Climate Action (BMWK) together with HINT.CO conducted a joint market consultation to share the current status of the foreseen tendering process and requirements of the upcoming H2Global tenders. During the virtual event, preliminary details about the tendering procedure, contractual arrangements and the product criteria to be met within the first tenders in the framework of the H2Global instrument were presented.

Due to the overwhelming interest, the maximum capacity of the virtual conference room was reached unexpectedly early in the meeting and led to technical issues. After a brief technical break, the market consultation was initiated and attended by participants from more than 40 countries.

Being in the design phase of the first H2Global tenders, HINT.CO and BMWK seek to have the most accurate understanding possible of the supply of and demand for green PtX products in the near future. To this end, HINT.CO and the BMWK conducted the consultation of international market players. Target groups were potential producers and off-takers of green hydrogen and PtX products.
